# Maryland Public School Critical Life-Threatening Incident After-Action Summary

On June 7, 2023 there was an incident within Prince George's County Public Schools (PGCPS) that met the criteria to be considered a *Critical Life-Threatening Incident* pursuant to Md. Ed. Art. § 7-1510 (g) and COMAR 14.40.05.

#### Notification [COMAR 14.40.05.04A]

On June 7, 2023 PGCPS staff notified the Maryland Center for School Safety (MCSS) of the incident.

#### After-Action Meeting [COMAR 14.40.05.04B]

On July 13, 2023, an after-action meeting was held involving school representatives, law enforcement, and a representative from MCSS.

#### After-Action Report [COMAR 14.40.05.04C]

On July 14, 2023 PGCPS submitted an after-action report to MCSS.

#### Lessons Learned

Based upon the after-action review led by PGCPS, the following lessons learned were identified by individuals participating in the after-action meeting:

- 1. Training and exercising school emergency operations plans should be conducted in coordination with the school community, including local responding agencies, school staff, and school system-level personnel.
- 2. Procedures for placing a school on lockdown should include procedures that account for students and staff outside the school facility when a lockdown protocol is initiated.
- 3. Schools should conduct regular assessments of video surveillance systems within and around school facilities to identify potential vulnerabilities, blind spots, or areas that may require heightened security measures.

Schools should work with responding agencies to test communication capabilities, including equipment (e.g., public safety radios), signals, and protocols, in an effort to strengthen communication among agencies. This testing should include school communication systems, i.e., intercoms, public address systems, and school two-way radios.
- 5. School emergency plans should include organizational structures and assignments for incidents. Once an incident occurs, if responsibilities are not already included in the plan, the responding staff should be immediately assigned their role in the response by the incident commander<sup>1</sup>.

#### **School Safety Recommendations**

- Local Education Agencies (LEAs) should include their respective response agency partners when conducting facility assessments, developing emergency operations plans, and conducting regular exercises that allow the school staff, the LEAs and response partners to test their school emergency operations plans. Attention should be given to the identification of roles and responsibilities as well as communication procedures used, for all responding school staff and agencies.
- 2. LEAs should draft crisis communication templates that describe the various school response protocols (e.g., lock-down, shelter-in-place) and share those templates with responding public safety agencies to ensure that the school, school system, and response agencies are using the same terminology when describing school actions during emergencies.
