The Maryland Safe to Learn Act of 2018, Senate Bill (SB) 1265, was enacted with the purpose of improving school safety. Under the Act, the Center is required to submit a report summarizing School Resource Officer (SRO) assignments within each local school system's jurisdiction for the 2018-2019 school year as well as the adequate local law enforcement coverage provided at those high schools that are not assigned a SRO.

Each local school system filed a report prior to the start of the 2018-2019 school year outlining SRO coverage at their high schools and the adequate local law enforcement coverage provided for those high schools that do not have a SRO assigned. Some local law enforcement agencies may use a different reference other than SRO but these officers, deputies, or school police officers perform the duties of a traditional SRO.

The majority of the public high schools in the State of Maryland have a SRO assigned to the school during the academic day.

For those public high schools that do not have a SRO assigned the local school system and high school in collaboration with local law enforcement have developed adequate local law enforcement coverage that is being provided to the public high school.

Local law enforcement adequate coverage varies from jurisdiction to jurisdiction but the outcomes are similar in nature and consist of the following:

- Roving local law enforcement officers, deputies, and school police officers assigned a geographic region where public high schools are located patrol the area of the high school during the academic day and will respond to calls for service at the schools. These officers, deputies, and school police officers are familiar with high schools in their regions. In addition, they can write reports while parked on school property or they can walk into the school for proactive positive engagement opportunities and outreach with students, administrators, and staff.
- Some SROs are assigned to a public high school but also provide SRO related-services and support to the elementary schools and middle schools in the feeder pattern of the high school or to those schools that are in close proximity to the high school.
- Some local law enforcement adequate coverage consists of Sheriff deputies working overtime to provide adequate coverage to high schools. This type of coverage is also supplemented by patrol deputies who would respond to calls for service at high schools not assigned a SRO.
- Local law enforcement agencies also provide supplemental patrol service and respond to calls for service at the public high schools when needed.
- SRO supervisors also provide supplemental patrol service and respond to calls for service at the public high schools when needed.

- Some Maryland State Police troopers are assigned to conduct school safety checks at public high schools in their area of patrol. These checks allow troopers to supplement SRO and local law enforcement coverage at public high schools. This opportunity also allows for proactive positive engagement and outreach with students, administrators, and staff.
- Some local school systems have allowed officers/deputies who are not SROs access to the school's Wi-Fi system so they can check emails and conduct other official business while at the school or on school property. This opportunity allows for increased patrol coverage of schools and proactive positive engagement and outreach with students, administrators, and staff.
- In any public high school critical incident/emergency especially when the incident involves a threat to life safety there will be additional officers/deputies who would be dispatched to assist the SRO in responding to and addressing the incident/emergency. In these situations, off-duty officers/deputies in the area may also respond to provide immediate assistance.

Some local law enforcement agencies are trying to hire new officers/deputies so they can then train and assign experienced officers/deputies as SROs.

Outlined below are tables which reflect local school systems high schools to include middle/high, alternative, vocational, technical, and special high schools that have an assigned SRO and adequate local law enforcement coverage provided for those high schools that do not have a SRO assigned.
