## 2022 Use of Force Report

The Maryland Center for School Safety (MCSS) provides the Governor and General Assembly data collected from local jurisdictions related to the use of force (UoF) between any school resource officer (SRO) or school security employee (SSE) and a student while the school resource officer or school security employee is carrying out his/her duties. There were 142 school resource officer use of force incidents reported during the 2021-2022 school year. There were 41 school security employee use of force incidents reported during the 2021-2022 school year. Analysis of this and preceding reports indicate the need for additional guidance and direction to local jurisdictions in order to ensure consistent and reliable reporting across all counties.
